### **Directors Report**

Mr. Samuel referred to the hand-out provided at the meeting, a letter to the Board of Supervisors and proposed ordinance regarding changes to County Code Chapter 10.04. Changes to the Code include provisions prohibiting picking or disturbance of plants or minerals in County parks, use of paint ball guns within 200 feet of any County park, the consumption of alcohol in County parks if deemed necessary by the Director, as well as giving the Director of the Parks Department the authority to ban skating, skateboarding, hang gliding, golfing and various other similar activities, and the authority to ban cats and dogs from County parks. In regard to the Director having the authority to ban activities or animals, language will be added by County Counsel providing that these issues must come before the Commission prior to enacting a ban. Mr. Samuel noted that the Board of Supervisors has approved the ordinance in concept, and that it will be considered for final passage at the Board's September 9, 1996, meeting.

### **F. Changes to County Code**

Director Samuel reported that this was provided for information purposes, and shows the new language added by County Counsel. The changes to County Code will be considered by the Board of Supervisors on September 10, 1996.

A community member addressed the Commission regarding the changes, noting that there is no provision mandating that the Director follow the Commission's recommendations regarding prohibition of various activities, or domestic animals, in the County parks. She further expressed the concern that the public be notified if the Commission is considering prohibition of dogs or cats in a park. Additionally, she urged the Commission to consider development of dog parks, which would provide fenced areas to legally exercise dogs off-leash, as well as clean-up stations.

In response to these concerns, Mr. Samuel noted that all Parks and Recreation Commission meeting agendas are publicly noticed, with a time allotted during each meeting for public comment. Commissioner Rosenberg noted that the speaker had raised a valid point regarding the direction that the Director bring certain issues to the Commission for recommendation, when no provision has been made that the Director follow the recommendation of the Commission.
