## **February 11, 2002 – Agenda**

### **Parks Building and Grounds Maintenance**

Staff spent time in December repairing protective fencing at Scott Creek Beach.

### **Status Report on Current Projects**

**Scott Creek Beach:** On December 4, 2001, the Board of Supervisors approved an amendment to the agreement with Reber Construction Company, Inc. The amendment allows the contractor to proceed with much-needed road drainage improvements. In addition, Caltrans has approved the drainage improvements and the County Planning Department has issued a minor variation to the existing Coastal Zone and Development Permit for the proposed changes. Work will resume on the project as soon as the road shoulder dries enough for proper compaction. All the remaining improvements will follow after the drainage work has been completed.

**Snowy Plover Protection Program 2001:** Perimeter fence adjustments, “exclosure” removals, and non-native plant removal are planned for the winter. Breeding season starts again in March 2002. The County will be more active on this perennial project in the spring due to reassignment of PRBO Biologist (reduced assistance) and necessity to construct brand-new exclosures. Scott Creek itself has “oxbowed” or “meandered” to the extreme south so far this winter and destroyed a good section of the Snowy Plover Area perimeter fencing. The fence has been moved further inland and fully repaired. A meeting with the Sheriff will be held at the beginning of the Breeding season to coordinate enforcement measures at the beach.

## **March 11, 2002 – Agenda**

### **Status Report on Current Projects**

**Scott Creek Beach.** On December 4, 2001, the Board of Supervisors approved an amendment to the agreement with Reber Construction Company, Inc. The amendment allows the contractor to proceed with much-needed road-drainage improvements. In addition, Caltrans has approved the drainage improvements and the County Planning Department has issued a minor variation to the existing Coastal Zone and Development Permit for the proposed changes. Work has resumed on the project and is expected to be completed by March 1, 2002, with the exception of a few punch-list items associated with the Highway 1 road shoulder.

**Snowy Plover Protection Program 2001.** Extending the plover perimeter fencing and preparing new exclosure fencing materials are high priorities right now. Breeding season starts again March 1<sup>st</sup>. The County will be more active on this perennial project in the spring due to reassignment of PRBO Biologist (reduced assistance) and necessity to construct brand-new exclosures. Scott Creek “oxbowed” or “meandered” to the extreme south this winter and destroyed a good section of the Snowy Plover area perimeter fencing. The fence has been moved further inland and fully repaired. Additionally, a meeting with the Sheriff will be held at the beginning of the breeding season to coordinate enforcement measures at the beach.

## **April 15, 2002 – Agenda**

### **Status Report on Current Projects**

**Scott Creek Beach.** The project is nearly complete with the exception of the highway signage, striping, and miscellaneous items. A site meeting is scheduled for March 19, 2002 to develop the project “punch list” of items remaining to be completed and any other minor site adjustments. As soon as the punch list items are completed, the project will be brought before the Board of Supervisors for final acceptance.

**Snowy Plover Protection Program 2001.** Preparing new enclosure fencing materials is a high priority right now as the perimeter fence has been extended and the breeding season officially started again March 1<sup>st</sup>. The County will be more active on this perennial project this spring due to reassignment of PRBO Biologist (reduced assistance) and necessity to construct brand-new enclosures. Scott Creek “oxbowed” or “meandered” to the extreme south this winter and destroyed a good section of the Snowy Plover area perimeter fencing. The fence has been moved further inland and fully repaired. Additionally, a meeting was held with the Sheriff at the beginning of the breeding season to coordinate enforcement measures at the beach. All signage is in place for park rule violators to be issued citations as necessary.

**Snowy Plover Protection Program 2002.** New plover fencing and protection materials have been purchased and two nests were protected this past month. We appear to be in a brief calm period in terms of breeding activity but we expect more nests to come imminently. Signage is in place for park-rule violators to be issued citations as necessary and Sheriff Patrols will be increased to full time during peak beach-use hours this summer. Additional small rules signs have been given to the Maintenance department for installation north of the Scott Creek Bridge.
